**STIPULATION PERMITTING
HOMEAWAY.COM, INC. TO
INTERVENE; AND [PROPOSED]
ORDER**

24 Plaintiff Airbnb, Inc. (“Airbnb”), Defendant City and County of San Francisco (“City”),
25 and non-party HomeAway.com, Inc. (“HomeAway”) stipulate and agree as follows:

26 1. WHEREAS, on June 27, 2016, Airbnb filed this action, seeking a declaration that
27 portions of a newly enacted San Francisco ordinance are invalid and unenforceable [Dkt. 1];

1 2. WHEREAS, Airbnb also filed a motion to preliminarily enjoin enforcement of the
2 ordinance [Dkt. 3];

3 3. WHEREAS, on July 1, 2016, HomeAway indicated it may seek to intervene in this
4 matter as a plaintiff [Dkt. 16];

5 4. WHEREAS, on July 1, 2016, the Court issued an order allowing HomeAway to file
6 a motion to intervene or complaint and request to relate [Dkt. 19];

7 5. WHEREAS, in lieu of a motion to intervene, Airbnb and the City have agreed
8 HomeAway may intervene as a plaintiff in this matter pursuant to Federal Rule of Civil Procedure
9 24.

10 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and among the
11 undersigned counsel as follows:

12 1. Pursuant to the parties' stipulation and Fed. R. Civ. P. 24, HomeAway.com, Inc. is
13 permitted to intervene in this matter.
